Juried Art Exhibit – October 12-13, 2019
Sullivan County Fall Festival, Blue Building
Sullivan County Fairgrounds, Forksville

1. Art must be original work and not previously exhibited at the SCCA Art Expo.
2. Major categories include but are not limited to: 2-D (painting, drawing, charcoal, pencil, ink, pastel, etc.); Photography (b&w, color, digitally enhanced), 3-D (ceramic, fabric, metal, leather, wire, stained glass beadwork, wood, etc.).
3. Photos of entries and an application must be sent for jurying by email: **helenday139@gmail.com** or by standard mail: **Helen Day, PO Box 139, Eagles Mere, PA 17731 (phone: 570-245-5694)**
Deadline for receipt of entry photos: September 30, 2019.
4. Art will be juried for artistic content, originality and craftsmanship by the SCCA art committee.
5. The SCCA art committee will determine the final number of categories, placement of art within categories, and the number and amount of cash prizes, which will total at least \$1200. Judging within the categories will be done by a panel of 3 judges chosen by the SCCA art committee. In the event that a category only has one artist entered in it, only one award will be given. A People's Choice Award will be determined by the votes of those attending the exhibit.
6. Accepted **artwork** and **\$20** (per three pieces) **entry fee** must be delivered **Friday, October 11 between 3 and 7 pm to the Blue Building, Sullivan County Fairgrounds, 4430 Rt. 154, Forksville PA 18616**. Please identify each piece with the artist's name, title of work, category and price or "NFS." The SCCA will collect 30% commission on all sales made during the exhibit.
7. Two-dimensional work should be framed, wired and ready to hang. Sculpture should be able to stand on a flat surface unless the artist provides a display stand.
8. Work accepted must be available for display during entire exhibit.
9. Entrants are expected to carry appropriate insurance on their art. Although the Fairgrounds has 24-hour security during the Festival, **neither the SCCA nor the Sullivan County Chamber of Commerce will accept responsibility for loss or damage to artworks during the exhibit.**
- 10. Artwork must be picked up on Sunday, October 13, between 4 and 5 pm at the Blue Building.**
11. By submitting the jury fee, entrant agrees to conditions set forth above.
